Terms and Conditions

All orders are subject to acceptance of Wear Ease, Inc.

Terms are net 30, from date of invoice and approved Wear Ease, Inc. credit application. Credit cards are also accepted. Credit card purchases will not be charged to the card until shipment. No minimum orders are required; however purchases under \$150 must be paid with a credit card at time of order.

In consideration of the extension of credit and establishment of a credit account, applicant acknowledges liability for payment of amounts due Wear Ease, Inc. for delivery of products of Wear Ease, Inc. products on credit terms as outlined. All overdue accounts are subject to a late fee of 1.5% per month (18% per annum) from the date due. Past due accounts will be transferred to Transworld System, Inc. for collections. In the event that it becomes necessary for Wear Ease, Inc. to bring suit or employ a collection agency applicant agrees to pay all reasonable cost of collection, including reasonable attorney's fees and court costs in addition to amounts due.

In addition, if applicant is more than 15 days late in making payment, Wear Ease, Inc., in addition to its other rights and remedies, may suspend deliveries until the account is brought current, together with accrued interest. Applicant will furnish additional credit information to Wear Ease, Inc. on request. Wear Ease, Inc. reserves the right to change credit terms at any time, including by requiring pre-payment, and applicant waives any right under statute permitting any specific or longer period to provide adequate assurance of payment.

Delivery Claims

All claims must be received within 30 days of shipment. All requests for proof of delivery must be received within 30 days of shipment.

Returned Goods Policy:

Acceptance of returned merchandise is at the discretion of Wear Ease, Inc. Returned merchandise will not be accepted for credit without a return authorization number, which can be obtained from a Customer Service Representative. Any request to return merchandise must be made within a *maximum 30-day time limit* from initial receipt of goods.

The following information is required for a return authorization:

1. Size and style # of the merchandise
2. Complete reason for the return
3. Return authorization #
4. Complete account information, including Trade Account Number, address, name of person making the return request and contact information
5. If goods are determined by Wear Ease, Inc. to be defective or non-conforming at time of sale, Wear Ease, Inc. will at its option replace the goods or credit your account. *No refunds will be given.*

The following applies to returns of all merchandise that is not defective or a result of a shipping error. *If goods are received damaged, soiled or not able to be re sold no refund will be given.*

- 20% of inspection and restocking charge on all returns if the merchandise is in the original packaging, is undamaged, unused and can go directly back into stock
- 30% inspection and restocking charge on all returns if the merchandise has not been used or damaged, but repackaging is necessary.
- 20% restocking charge on refused orders, including orders canceled after acceptance
- Refused orders, including orders canceled after acceptance, are also subject to 20% restocking fee

ANY ACTION FOR ANT ALLEGED BREACH OF ANY CONTRACT OF SALE OR OF THE ABOVE REFERENCED WARRANTY IN RESPECT OF THE PRODUCTS MUST BE COMMENCED WITHIN ONE (1) YEAR OF THE DELIVERY OF GOODS.

Terms and Conditions will be constructed and enforced in accordance with the laws of the State of Idaho. All claims that cannot be resolved by the parties amicably will be adjudicated exclusively by the appropriate Idaho State or Federal Court. By submission of a Credit Agreement or Purchase Order, you submit to the personal jurisdiction of such courts for resolution of any claim, and agree not to contest venue as appropriate in Boise, Idaho. The parties waive the right to a trial by jury.

By submission of a Credit Application or Purchase Order, you agree to the Terms & Conditions. Wear Ease, Inc. accepts orders only pursuant to the Wear Ease, Inc. Purchase Oder Form, and all conflicting Applicant terms are rejected.

Prices, discounts and terms may change without prior notice, all prices quoted and payments to be made in US dollars.

You agree to notify Wear Ease, Inc. immediately with any changes to information provided in this Agreement.
